CARI AI Privacy Policy

CARI AI is committed to safeguarding the privacy of users' personal information obtained through the website. We pledge to adopt a confidentiality policy as outlined below:



1.2 - Use of Cookies and Activity Files. Web Page Monitoring

The website uses third-party cookies like Google. Cookies used by the website are files sent to a browser via a web server to record user activity on the website, allowing for smoother and more personalized navigation. Users can configure their browser to block these cookies, or, if applicable, delete them. The use of the website does not require users to allow the download or installation of cookies.


CARI AI pursues profit, gain, or commercial interest with the contents or links published on its Website and the websites of other dependent or affiliated entities, which are accessed through the Website.


